In supersession to this University Notification Number BPUT/ Exam / 1935/2020 dated 06.06.2020 and consequent upon decision of the Government of Odisha in Skill Development & Technical Education Department communicated vide letter No SDTE-HTE-HTE-II-0012-2020/ 2498/SDTE, Bhubaneswar dated 19.06.2020, I am directed to inform all concerned that the Final Semester Theory Examinations: 2019-20 for all Courses will be conducted tentatively from 1st week of July, 2020 onward on-Line with open book system and set of innovative questions based on outcome based education, which tests the applied knowledge of the students.

The students who opt not to appear in the above said on-line examination can appear in the offline final examination of the University after re-opening of the educational institutions.

Sub: Conduct of final semester examinations in BPUT and VSSUT during COVID-19 pandemic.

Sir,

With reference to the subject mentioned above, I am directed to inform that the Government have been pleased to accord approval to BPUT and VSSUT to conduct the final semester examination of all courses online to give an exit opportunity to the final year students for furtherance of their career.

The Universities may conduct these examinations online with open book system and set of innovative questions based on outcome based education, which tests the applied knowledge of the students. Students shall be allowed to appear the examination from their home.

The Universities shall devise their own pattern for conducting the aforesaid online exams based on the recent guideline issued by UGC/AICTE for the COVID-19 pandemic situation, ensuring security and proper preservation of data in their own server.


Since, adequate broadband or internet connectivity may not available in the interior rural and hilly areas of the State, the disadvantaged students may be allowed to use the broadband / computer facilities of the technical /professional institution and Govt. ITIs/Polytechnics nearest to his/her home as per their choice.

For this, the University shall publish a list of such institutions, with at least one institution per district, for providing adequate opportunity to the students of interior pockets to appear in the online exam successfully.

The students who opt not to appear in the above said online examination can appear in the offline final examination of the University after re-opening of the educational institutions.

The Universities are hereby requested to conduct these examinations tentatively during the first week of July 2020 and declare the result by the end of July, 2020.


